The NIST Cyber Security Framework

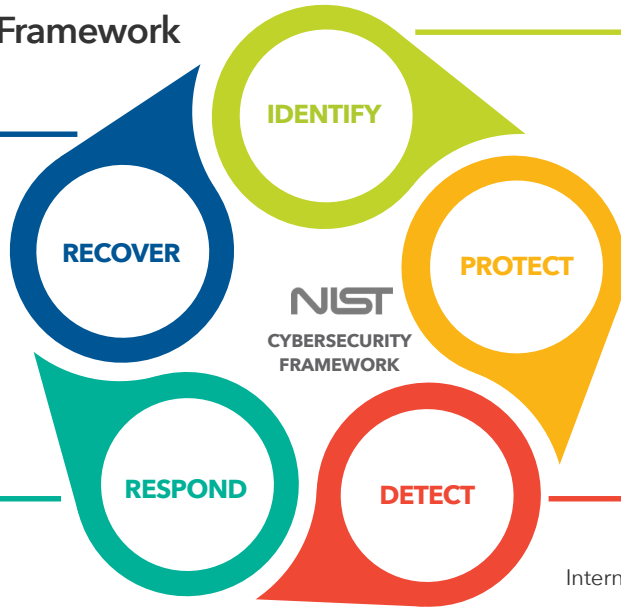
